BUSINESS ARISING FROM CORRESPONDENCE

Rob Pekaar has written to the Delegates Council requesting that he and Peter Pekaar obtain and hold Dry Casting Perpetual Trophies for a period up to six months

Moved...Terry Fuller; Seconded; Richard Siudak "That the two Dry Casting Perpetual Trophies be released to the Pekaar family for a period of six months. A written undertaking to be set up" Motion carried.

Mark Hansen queried big fines for lobster fishing. John Curtis indicated that a couple of anglers were fined \$23,000 for pulling other persons pots and selling rock lobster on the black market. They also lost boats & equipment and were banned from holding or obtaining a recreational fishing license for 12 months.

Terry Fuller gueried the linet Account of 2 December.

Richard Siudak indicated that the account had been paid but linet had misplaced the cheque. It had been placed in the Orphan Register although the account number was placed on the rear of the Cheque.

Mark Hansen queried letter from 6 Dec re AAA Annual Membership John Curtis indicated that the Association is entitled to 10 annual memberships and the list of names was to be updated.

John Curtis reported on discussions with Recfishwest regarding benefits for Association members under changes to the membership categories of Recfishwest. Now association members are able to become full voting members of Recfishwest at a discounted rate. It will require clubs to pay the fees to the Association who will pass the details and fees on to Recfishwest. (See attached copy of Recfishwest minutes of Board Meeting 25th November 2013)

11. INDIVIDUAL REPORTS

President's Report

John Curtis reported on a meeting with Andrew Rowland at Recfishwest where he discussed the Ocean Reef re-development project and other items.

He took the notes from the last Delegates Council relating to the Ocean reef Marina redevelopment and requested that these points be raised with the Shire at a meeting to be held on the coming Friday.

RFIF Meeting

John Curtis reported on the RFIF meeting held on the previous Thursday and made available the notes and PowerPoint presentation to delegates. Funding for many new projects relating to recreational fishing was discussed at this meeting and allocated to various project. These included restocking recreational species, installation of FAD's in off-shore and near shore waters as well as several new research projects.

Estuary, Rock and Beach Report

Jason Pember has posted cheques received at the state estuary competition. He also indicated that he also had \$20 cash from Melville competitors Wilf Core and Des Grey which will pass on at the next meeting.

The estuary event went reasonably well with around 57 competitors, still difficult to encourage more people to attend the estuary in the Swan River. No fish were caught by the juniors and minis so we still have the prize vouchers. The sub-committee will have to start organising the next State Beach Championship event which will be done in the near future, particularly the briefing/weigh-in venue.

Boating Report

No changes to the demersal catch in the rules.

No meeting in January, any news will be disseminated via electronic means, February meeting will be a meeting that all volunteers for the State Boat Angling Championships are requested to attend so we can ensure the "normal" smooth operation on the day, and all are aware of their roles.

Delegates and clubs are to note that it is the last chance for non-boating club members to apply to fish the State Boat Angling Championships in March. i.e. club members intending to use charter boats to fish this event need to apply to the Boating subcommittee giving three 3 months notice.

The Nomination Rules state that charter boats are not permitted unless there is a nominated non fishing AAAWA Auditor on that boat and an application has been presented to the AAAWA boating sub-committee three months prior to the event. It should also be noted that the two dhufish per boat also includes those fishing on charter boats. Other dhufish caught are to be quarantined and cannot form a part of the catch unless the rules are changed for recreational boats. (Charter boats may retain 6 Dhufish), this Charter Boat Rule, shall be assessed on merit each year and area. Can all potential non-boating club participants please get let Pat Shinnick know as soon as possible if you intend to use a charter boat in the March State Boat Angling Championships.

Dry Casting Report

George Holman reported that feedback from the recent de-brief meeting held recently, indicated that generally everyone is happy with the event. A request for another laser

All trophies have been engraved are now back in Pat Shinnick's premises.

Recording Officer Report

John Curtis reported that he had received an email from a Busselton angler indicating that he had caught a potential State record pink snapper.

It weighs 20.05 kg, and was caught in 15 metres of water in Geographe Bay. Gilled and gutted it weighed 17.05 kg, length was 1.07 m. and it took 25 minutes to land. It was caught **Sunday 15 December 7.47** (am) and therefore is an illegal capture as it was caught during a Department of Fisheries declared closed season.

Terry Fuller indicated that it was an illegal catch as the West Coast Demersal seasonal closure was still in force. Many people went out on Sunday presuming that it was closed 15 October 15 to December and did not read the word "*inclusive*".

John Curtis reported on a phone call received from a MAAC member relating to scale calibration, indicating that due to changes to regulations he felt that scales once calibrated did not need to be recalibrated again. This is not so as that only applies to scales used for retail sales.

A note on page 9 of the consultation papers, *National Trade Measurement Regulations* indicates that this is the case for retail sales only. This does not apply to clubs affiliated to the Association. It should be noted that any potential record fish applications should be weighed on scales that have been initially calibrated and then re-verified at predetermined intervals.

Following discussion the recorder is to draft a set of guidelines and report back to the Delegates Council.

John Curtis reported that he had a State Dry Casting Record certificate to present to Peter Pekaar for a new State Record for level line distance up to 112 Gms when he cast at a recent club event of 199.82 metres.

He also had a State Record Certificate for Peet Wessel's, from the S C A C for a Surge Wrasse weighing 1.31 kg. It is an augural State and National Record.

He also had a State Record certificate for Vince Longo for a banded groper weighing 4.63 kg, caught at Coral Bay. A national record certificate will be posted just after Christmas.

Robert Schoennfish, from South Australia, had lodged pictures and a cheque, presumably for a State Record. As there was no record application form with these, both the pictures and the cheque were returned.

12. GENERAL BUSINESS

Potential Name Clash with the Association's Name.

It was noted that the Australian Asian Association of WA Inc has an entry in the City of Stirling Community Directory as follows:

Australian Asian Association of WA Inc: Web address is; www.aaawa.org.au – after discussion it was resolved that it was not worth approaching Dept. of Commerce for clarification.

Materials to be purchased by the Association:

Following discussion with Pat Shinnick and the Boating sub-committee, it was agreed that the Association needs to purchase some equipment for use at its events. It has been agreed that we need to purchase the following items;

- A portable PA system and two speakers with a minimum of 60 W of power with two head set microphones. It will also need to be battery powered so that it can be used at all AAAWA events at any location.
- The Boating sub-committee also requires approximately 10 m of concertina barrier fencing.
- It was also recommended that the Association purchase a Laser measuring device for use at State and Club dry casting. It could be possible to purchase a second hand unit.

- Additionally it was noted that the Association should purchase a set of 15 kg scales and made available for use in all the Association events apart from Dry Casting.
- A recommendation was also made to purchase set of Standard Weights. These
 would allow the Association and clubs to carry out comparison checks on scales. It
 was recommended that the Association purchase 1 x 1 kg, 2 x 2 kg, 1 x 5 kg, and 1
 x 10 kg standard weight. Cost would be around \$350.

It was recommended that an application be made to Recfishwest for a small Community Grant to help fund these purchases. After a prior discussion with Recfishwest regarding Small Community Grants, it was noted that the opening date for applications have been postponed possibly until mid April.

Terry Fuller notified the meeting of the demise of Des Wood, who was a board member of Recfishwest from 1997 – 2009 and Chairman from 2003 -2007. His funeral will be held at All Saints Church in Greenwood and followed by a burial in Pinnaroo.

Paul Longo asked if delegates knew what was happening with the Two Rocks marina wall. Both the boat ramp and the marina wall were to be repaired and are still not yet completed. Terry Fuller indicated that as he understood the concrete panels were unsuitable and apparently the contractor had been sacked. It was resolved that a letter be sent to the Minister of Transport along with a drop copy to Recfishwest relating to works being undertaken at Two Rocks.

John Curtis had followed up on the North Mole closure. He had rung and had spoken to the project engineer and was told the North Mole was still closed at this point in time. He will be advised when it is to be opened.

Joe Horvath asked what measures were in place to stop anglers participating in Association events from 'pegging out' beaches before a State Competitions starts? Competition Rules not that the practice is not acceptable and needs to be recorded and reported to the organizing committee. It was also noted that where possible take a photograph to support any complaint lodged.
