#### Recfishwest Report.

Terry Fuller reported on some of the main points from the February 2006 Recfishwest Board Meeting, and other recent activities.

The Recfishwest Board had a breakfast meeting with the Minister for Fisheries. The Minister gave us an insight into many of the things he is working on, including the commercial wetline review, wilderness fishing, Marine Parks, fish habitat protection areas, commercial fishing in the Swan River and Cockburn Sound, commercial salmon and herring fishing, Rottnest no fishing zones, the Labor Party's commitment to its fisheries election promises, illegal foreign fishing, compliance, metro management (Zone 5) proposals, spatial separation and allocation of areas to recreational anglers, etc. His approach to many topics would be of great encouragement to recreational anglers. Outcomes of these will be reported as they are announced.

Fisheries Minister Jon Ford has given the community a final opportunity for input to determine management arrangements for Western Australia's commercial scale fish (wetline) fisheries. The papers are available from the Department of Fisheries website. Recfishwest will be preparing detailed comments on the updated proposals. Comments need to be submitted by 24 March.

Recfishwest held a strategic directions seminar in December. As a result there are proposals for changes to the composition of Recfishwest's Board. These include expanding from the current 11 to 13 members plus the chairman. One would be an additional association Board position for either the Australian Fishing Tackle Association OR the WA Charter Boat Association. The other would be an additional public member who would be allowed to be a member of a fishing club or association, which is not currently possible. Recfishwest has also moved to handle the decline in some Associations and to make some of the five association positions available to other associations which are currently not represented.

Integrated Fisheries Management continues to be a major activity. The next submissions on the Western rock lobster papers is well advanced. There has been a lot of activity on abalone IFM, including vigorously challenging and heading off unjustified extra allocations to the commercial fishery in advance of IFM which would have had a major impact on the outcome in terms of the catch share.

Rottnest no fishing sanctuary zones have been a major issue as reported in detail elsewhere and will be ongoing.

Submissions have been put in on the closure of Logue Brook dam to recreational fishing and other recreational activities.

Recfishwest has been present at a meeting to discuss changes to the Shoalwater Marine Park in the Rockingham Safety Bay area, and has resisted plans for increased no fishing areas.

Recfishwest travelled to Karratha for the final meeting to discuss the zoning for the Dampier Archipelago Marine Park. Indications are that the proposals have really taken account of the community's concerns, and represent actions that the community can support and will be prepared to take ownership of and help to police.

A meeting was held between Recfishwest and senior management of CALM Recfishwest's comments on the Premier & Cabinet Discussion Paper: Bioregional Marine Planning in Western Australia and working towards getting a fairer, better, more scientific, objective and more effective way of deciding what really needs to be done to preserve biodiversity and manage fishing pressure and everything else affecting biodiversity and fish stocks than the current very dissatisfactory Marine Parks process.

Recfishwest has written to the Minister and asked for cobbler to be protected in the Swan and Canning Rivers.

Recfishwest has written to the Minister and asked for commercial salmon fishing to be suspended over Easter and the April school holidays.

Recfishwest's draft policy on Catch and Release fishing has received some favourable comments from the public, and is being finalised.

Recfishwest has prepared a draft policy on Artificial Reefs.

Recfishwest has written to the Minister for the Environment asking for action to control the building of dams on winter creeks for the benefit of freshwater species including Marron.

Frank Prokop attended a released fish survival working group meeting in Brisbane and came back with the a lot of information about research on the survival of fish, the ability of fish to handle hooking in various parts, and best practices. This information will be distributed and used in information brochures.

Frank showed information about the samson fish tagging program, run off Rottnest, to his counterparts in other States who were astounded at the fishery, the quality of the research and the tremendous amount of recreational angler participation and cooperation.

Recfishwest has been advised it will receive a grant to promote "get hooked on fishing not drugs" in conjunction with its very successful fishing clinics which are run in many parts of the State.

A summary of the proposals for the West Coast Commercial Wetline Review was distributed to the delegates. These are the almost final proposals which have been made public by the Minister for Fisheries giving the public one last chance to comment on the proposals before he makes up his mind

There have been some changes from the previous draft versions of these Fisheries Management Papers FMP189, 190 and 191 which went out for comment in January 2005. One very significant change deals with the rights of the commercial fishermen who do not get licences to be part of the future commercial Wetline fishery to be able to take demersal fish from their commercial boats while they are out on the water doing their other commercial fishing as though they were just ordinary recreational anglers. There is a very large potential catch which will have serious ramifications for the sustainability of the fishery and the share of the fish which is available to both of the licensed commercial Wetline fishers and the ordinary recreational anglers.

Up until now, there has been almost complete apathy and lack of response by the people and clubs who have the most to gain or lose from the management of Commercial Wetline fishing.

To all those vocal people who have said all those things and their concerns about commercial fishing for dhufish, snapper and other fish covered by the West Coast/Gascoyne Demersal Scalefish Fishery and Inshore Net Fishery as defined in the Management Papers:-

This may be your last chance to comment on the management of the West Coast/Gascoyne Wetline Fishery which IS SO IMPORTANT, PARTICULARLY TO PEOPLE AND CLUBS WHO FISH FROM BOATS.

After all, if you didn't take the opportunity during these two separate public comment periods, why would you expect your complaints to be listened to afterwards if you couldn't be bothered to make them during these periods?

If you feel daunted by all the detail, I suggest you start with FMP 206, West Coast, Section 2 and look at the summary recommendations numbers 10-15, 18-24, 26-27 first. If you can handle those, then the rest are much easier.

Send me any questions and I'll try to answer them including extracts from/links to previous stuff.

Please don't leave this to "someone else" to comment. If you do leave it to other people, and you don't like the outcome, then..... Submissions close on 24 March.

The written outcomes of the Dhufish Workshop run by Recfishwest some time ago should be available soon. Pat Shinnick presented a recreational anglers perspective that workshop. There is some really good information available in the paper and shows what the problems are for Dhufish.

#### **Business Arising from RFW Report.**

Just discussions on some details of commercial licences and potential "recreational" catch by people who don't get wetline licences and the importance of the Wetline review to recreational anglers, bycatch of species.

George Holman said that the Recfishwest reports provide great amount of information and it is surprising that there has been so little reaction from the clubs to some of the very important issues being raised.

Terry Fuller will investigate released fish survival information.

Some more details were given on the Rottnest proposed no take zones – proposals will be released mid March. All the information is in the handouts.

#### General Business.

#### Statement by AAA Secretary / Treasurer / Website Editor.

Secretary / Treasurer / Website Editor Terry Fuller gave written notice as follows:-

After doing the above Australian Anglers Association jobs for three years, it's time to move on, to look after myself and give myself some time and have some energy left over to go fishing again and do more of those other ordinary things in life.

I advise the Delegates at this February meeting that I will not be volunteering for, and I will not accept any nomination to be the AAA Secretary or Treasurer or Website Editor at the August Annual General Meeting. I will stop doing any of this work and I will not do those jobs from the date of the Annual General Meeting when all positions are declared vacant before running the elections for new people.

This gives five months notice to find replacements, and for those people to see what is required and do whatever preparation they want. I will help new people as much as I can to take over these jobs.

I do realise that not doing this work may present a really major problem for AAA due to the extreme lack of volunteers prepared to do work in recent times. I thank the people who have supported me in what I have tried to do while working for the Association.

However, it is time, and it is necessary, for me to move on and to leave the work of the Australian Anglers Association to others if they think it is worthwhile to continue supporting the Association.

I am prepared to be the Recfishwest Board Member representing and reporting to the Australian Anglers Association if the AAA Delegates want that. Whatever decision is made, I will continue to work actively with Recfishwest in some capacity, and I will devote more time to work being done by Recfishwest which is extremely important for the future of recreational fishing in Western Australia.

I have also advised the members of the Surf Casting and Angling Club that, after being on that club's Committee and Secretary for nearly 6 years, and doing nearly 5 years as the Editor of the club magazine Reel Talk, I will not be a Committee Member or an officer of that club after the next elections in July 2006. This gives the Club four months' notice to find some people to take over. I will offer to remain as one of that Club's delegates to the Australian Anglers Association if the club members wants that. However my work as an AAA delegate will be limited to representing the club, and will not involve doing any of the great range and amount of extra work I have done for the Association in recent years.

It is time, and it is necessary, for me to move on.

#### **Future of AAA.**

Acting chairman George Holman read out the following three paragraphs from the minutes of the January Delegates Meeting. He pointed out that this summarises the very serious situation with the Australian Anglers Association and the involvement of the affiliated clubs and with recreational fishing in general.

"Changes to the Recfishwest Board and impact on AAA. The Recfishwest Board is considering how to adapt the membership and the structure of the Board to changing circumstances. In particular it wants to handle the changes in the Associations which provide five members to the Recfishwest Board, and open membership to other associations and organisations which are currently not directly represented on the Board. Also the need for better communications with the public to counter the extreme apathy among recreational anglers which is apparent and which will have serious impact on allocation and sharing decisions.

The outcome of this is that declining Associations may find their place taken by other organisations, either temporarily or permanently. With the current severe lack of volunteers and lack of delegates attending meetings of the Australian Anglers Association, and the lack of any people to take over important positions such as President, Secretary, Treasurer, Rock, Beach and Estuary subcommittee chairman and Boating subcommittee chairman when the current people step down or burn out, this proposal has significant ramifications for AAA in the future.

AAA has a very good working relationship with Recfishwest at present, and despite the severe lack of interest, feedback and involvement of AAA clubs in the management of fishing, AAA club member's interests are, as far as they can be guessed, covered to some degree in Recfishwest's submissions and activities. Without the involvement of AAA in Recfishwest there is no guarantee that club members' interests will be considered unless there are other avenues found to get their opinions through to Recfishwest."

This is crunch time for AAA. AAA would not exist except for the involvement of the affiliated clubs and delegates who volunteer to do the work of the AAA. Might need to look at a Special Meeting of club Presidents and Secretaries, maybe in May or June to decide if the clubs want the AAA to continue. May need to send out an independent letter to the Clubs setting out the problem.

There was discussion on contact with the clubs. George Holman's life threatening knee infection and prolonged convalescence and recovery and need to catch up with his personal and working life had Minutes of AAA Delegates Meeting held 21 February 2006

interrupted and prevented the plans for the President and Secretary to go around to many of the clubs. Now there is no President.

There is a feeling that some people believe that things are being handled OK due to the good work being done by the Secretary and the detailed reports being distributed, and there is no need for them to be involved. This is an absolute no-win situation because doing a good job means that there is no support for the things that are not being done and there is no succession plan possible for people to take over the work.

The visitors from Melville advised that they found the visit from AAA Secretary and President to their club meeting to be very informative. Melville also has problems with the number of workers, with only 6 or 7 putting in 95% of the work. The top priority has to be the running of their club. Any extra work done for AAA can only be at the expense of the club. Clubs have problems with getting and keeping new members. If the clubs are not strong, then the Association cannot be strong. Competition and mateship are the important things which help to keep the club together.

Other delegates present said their clubs had similar or even worse problems with a lack of workers and new members.

It was suggested that Delegates present here tonight should contact other clubs and advise them of what is happening. George Holman is prepared to go to clubs to talk direct to the members and officials.

Martin Humbert asked how many clubs actually distribute to their club members the information provided by AAA so that the members know what is going on? The Surf Casting and Angling Club does, but it seems that few if any other clubs do this, and some have actually refused to include the information in the newsletters.

Graham Maunder from Geraldton has contacted the Secretary and been provided with some information on running a fishing clinic. It is hoped these would be funded by the local Council.
