## 12. INDIVIDUAL REPORTS

### President's Report

John Curtis provided the following report prior to the meeting via email:

- John Curtis and Alan Jones have gone through the contents of the new Dry Casting Trailer (ex Victoria AAA) and prepared an inventory
- Alan Jones and Malcolm Head from SCAC will go through the 300 odd markers that are not currently suitable for use and refurbish them.
- The trailer registration needs to be transferred from Victoria to WA
- If clubs wish to use any of the equipment, they can either purchase it outright or hire it from the AAAWA, which will assist in recouping some of the cost of the transfer costs.
- John requested notification from clubs about their willingness to assist with the state hosting either the 2015 or 2017 National Championships and Convention (see General Business)

### Estuary, Rock and Beach Report

- Don Cox advised that a meeting will be held on Wednesday 22<sup>nd</sup>.
- Approval has been given by the Dandaragan Shire and DEC regarding the competition at Jurien.
- Participants should note that camping is prohibited at Beekeepers Reserve (between Cervantes and Black Point) and rangers will be active in the area.
- George Holman encouraged all clubs to participate and support the event organisers

### Boating Report

- Pat Shinnick advised that plans for the Boating Championships in March are proceeding well
- Support has been received from the local community and council, football club and sea rescue group
- Prizes are organised
- Volunteers have come forward to assist on the day.
- Pat Shinnick will be the contact person for police or emergency matters and senior first aid officers will be present
- The management plan has greatly assisted in the organisation of the event.
- George Holman wished Pat and his organisers all the best with the event.

### Dry Casting Report

- George Holman advised that the recently received Victorian AAA trailer will require new tyres, a jockey wheel and new wiring
- He believed it was a better unit than the existing trailer and included a quantity of rope which can be purchased or obtained for a donation.
- Sinker moulds can be loaned to clubs
- The existing trailer can be sold as is and the new trailer needs to be licensed, which will require it going over the pits.
- Peter Stoeckel suggested that a cover be put over the trailer when not in use
- George will hold a meeting shortly to start planning for the next Dry Casting event

## **Recfishwest report for AAAWA Delegates Meeting**



**21 February 2012**

### **State-wide management proposals for recreational fishing**

A Fisheries Management Paper (FMP) covering the Department of Fisheries' proposals for recreational fishing throughout WA was released on Wednesday 22 February.

Recfishwest has not yet formed a position on this proposed management approach, but has been requested, as the Government recognised Peak Body for Recreational Fishing in WA, to provide consolidated, independent advice to the Department of Fisheries in a single document based on the views expressed in community consultations to be run after the release of the FMP.

A review panel of representatives from the Department of Fisheries and Recfishwest will consider the submissions received to ensure all issues are taken into consideration.

The Minister will consider this advice along with advice from the Department of Fisheries before making decisions on the future management of recreational fishing. Here are some links:-

There are many details, and first media reports contained some significant mistakes. Please do not believe everything you read on the internet or in the media, see on TV or hear on radio.

Although Peak Recreational Fishing body Recfishwest will be running the community consultations, it is stressed that the proposals come from the Department of Fisheries, NOT from Recfishwest, and RFW will use community comments in deciding its response to the proposals.

As reported in the West Australian:- *WA's recreational fishing lobby Recfishwest was cautious in its response to the review, saying it supported simplifying current arrangements but had reservations about some of the proposed restrictions. Recfishwest's acting chief executive Andrew Rowland hinted the group might seek to challenge some aspects of the plan, urging fishers to submit feedback during the review's two-month consultation period.*

### **Retirement of Fisheries Minister Norman Moore**

Mr Moore has announced he will retire from State Parliament on 21 May, 2013 when his current Legislative Council term concludes. As Fisheries Minister, he has been a strong supporter of the recreational fishing community, and peak body Recfishwest is looking forward to continuing to work closely with the Minister during the remainder of his term on numerous exciting projects which will have long-term benefits for recreational fishing in WA.

### **Small community grants**

Three extra Fish Aggregating Devices (FADs) will be deployed off the WA coast between Cervantes and Jurien Bay, funded by recreational fishing licence funds. RFW is pleased funding has been granted for projects from Esperance right through to Kununurra and is hoping to call for another round of projects in the next few months.

### **Recreational large fishing grants for in-depth projects**

More than \$1 million in revenue raised by recreational fishers purchasing licences, such as recreational fishing from boat and rock lobster licences, will be used to fund large projects to enhance recreational fishing.

Recfishwest encourages incorporated individuals, research institutions, fishing clubs and community groups to apply for the grants. Applications which demonstrate the support of local recreational fishers will be given preference while

funding will be provided to projects that are beneficial and cost effective to the recreational fishing community. Applicants can apply for a grant of up to three years duration and projects are expected to commence on July 1, 2012. Forms are available at [www.recfishwest.org.au](http://www.recfishwest.org.au)

### **Western Rock Lobster Reference Group**

Recfishwest has sought expressions of interest from recreational fishers to hold positions on a reference group for the recreational western rock lobster fishery. The reference group will provide advice on the management of recreational fishing rock lobster.

Appointments will run for three years on the group that will comprise eight members, including one Recfishwest board member and a chairman nominated by Recfishwest. Members must be able to make clear and concise recommendations to Recfishwest as well as provide advice on the management and mitigation of these issues.

One of the main objectives of this group is to give advice on how recreational fishers would like to see the recreational catch best managed within its allocation under Integrated Fisheries Management.

Another reference group provided advice on management of the Marron fishery for 2012. Reference groups for other recreational fisheries are likely to be established under proposals for RFW in its role as the Government recognised Peak Body for Recreational Fishing in WA.

### **Identifying the health and well-being benefits of recreational fishing. Fisheries Research and Development Corporation Project 2011/217**

Delegates will be aware that official funding for and recognition of sports and activities sometimes depends on the benefits or returns which can be expected, and supporting research is often required. An extensive review of published literature revealed virtually no research that quantified the health and well-being benefits of recreational fishing.

Recreational fishing is a popular form of outdoor recreation enjoyed by Australians, and is one of the few forms of nature-based recreation that can be enjoyed throughout childhood, adolescence, adulthood and into the senior years. Of recreational fishers aged 50 years and over, 75% have been fishing for longer than 30 years amassing a wealth of skills, techniques and knowledge build over the years of participation.

As a part of this project, researchers from the Centre of Excellence for Science, Seafood and Health contacted many stakeholders in recreational fishing in order to collate a considerable amount of anecdotal evidence supporting the positive influence recreational fishing has on health and well-being.

The study found that considerable health and well-being benefits can be gained through involvement in recreational fishing. Encouraging young children, youth, adults and families to fish offers a cost effective and healthful outdoor recreational activity that can be enjoyed throughout life. Benefits were evident for individuals and groups. Recreational fishing was also noted to provide significant benefits to children and youth with behavioural and mental health issues. Finally, educational strategies that focus on how to minimise the environmental impacts of recreational fishing can ensure today's and tomorrow's recreational fishers are aware of sustainable fishing practices.

### **Recfishwest staff development**

Recent RFW appointees Ellen Smith (Regional Policy Officer) and Joachim Azzopardi (Communications Officer) have both been successful in their applications for this year's National Seafood Industry Leadership Program. This program is funded by the Fisheries Research and Development Corporation on a competitive basis and RFW are very fortunate to have two representatives from the recreational sector.

This program is very well regarded and is focused on professional development in the context of aquatic resource management which will provide a great return to Recfishwest. Other graduates have gone on to apply their skills to a wide variety of areas including regional network development, regional and state industry association boards and reference committees and effective business management.

### Business Arising from RFW Report

- Pat Shinnick queried what consultation anglers will have with Recfishwest as part of the statewide management proposals for recreational fishing and Terry Fuller reassured him that there would be briefings and a two month consultation period with plenty of opportunity to argue against the Fisheries Management Paper
- Pat argued that ordinary people would not be listened to and that only RFW and other professional bodies would have a say. He also believed that many of the changes would affect boat fisherpersons who would prefer angler limits to boat limits. He stated that everyone wanted an opportunity to consult and asked that as a board representative, Terry Fuller represent AAAWA effectively.
- Terry Fuller responded that RFW is a government recognised peak body and will do community consultation such as meetings, internet surveys, etc.
