Russell Bunce (Fremantle Amateur AC) asked that the following email be read to delegates:

Fremantle club lost one of its longest serving members last week. Mr George Brown passed away 12th January at the age of 95. George was a life member of our club as well as club patron, joining in 1963-64 season. Some of George's achievements:

- The first state team to represent Western Australia at the national championships was led by George as captain. The team won the beach section and gathered enough points in the other sections to become the Australian champions
- Elected in 1973 as president of the AAA WA Division a position he held for four years. When the National Championships were held in WA in 1975 George became National President of AAA
- In 1977 George won the champion Veteran's Beach Competition at Caloundra in Queensland
- State Angler of the year in 1978
- Helped organise the national championships at Albany in 1975
- Elected as President of Fremantle Club in 1972 1974 , 76 78
- Inducted into the Fremantle Sporting Wall of Fame for his contribution to fishing

George loved his fishing right to the end and as stated above was a dedicated member of the AAAWA.

President's Report

John Compton was absent - no report

Estuary, Rock and Beach Report

The State Beach and Rock competition is on 5th & 6th March 2011 at Cheynes Beach. Discussion took place regarding the compulsory briefings and it has been decided by the subcommittee that participants must sign on in person. The weigh in can be done by the club captain, but all bags must have their AAA tag attached. Individual forms must be completed and returned to Jason Pember by 25 February 2011. Forms are on the website. A reminder will be sent to AAAWA clubs advising them of the details.

Further discussion took place about the dates for the 2012 event. (Refer to December 2010 minutes). It was reported by Terry Fuller that the Boating Subcommittee has made their decision, their event will be held on the March 2012 long weekend on Saturday, with the Sunday as a reserve. Delegates considered that potential problems having two major AAAWA events (Rock & Beach and Boating) on the same long weekend include:

- Poor weather conditions can cause the Boating Competition to be postponed to the next day.
- Accommodation and weigh-ins are complicating factors.
- People may want to fish in both events putting them at a disadvantage.

It was moved by Terry Fuller and seconded by Jason Pember that the 2012 Rock & Beach Championships be held 24/25 March 2012 at Jurien. Motion carried.

Boating Report

- Pat Shinnick has requested via email that the delegates approve his purchase of 100 (or more if required) Weigh In booklets from his supplier as he needs these for the State Boats Competition in March. (see sample attached). It was moved by George Holman and seconded by Mark Hansen that Pat Shinnick be authorised to order 100 Weigh In books. Motion carried.
- Terry Fuller advised that nomination forms for the State Boating Competition are on the AAAWA website

Dry Casting Report

- Terry Fuller advised that the minutes from the Dry Casting meeting had been prepared and distributed. If anyone has any comments please get back to him.
- George Holman advised that the Veterans Dry Casting shield has been located which has been sent to Trophy Choice for updating.
- George Holman is planning a meeting for those interested in going to the Mid Term Convention at South West Rocks, NSW. Monday 7th Feb at 8 pm. Rear of 89 Clontarf St Sorrento.
- John Curtis has been communicating with Robert Smith and Margaret Riddell as to the program, which has changed over the last month back to the original program. The casting date will be on the Monday and Tuesday before the Convention on 8th August (Accuracy) and 9th August (Distance) on the grounds adjacent to the Port Macquarie airport.
- The executive meeting is at the start of the Convention.
- George has received 15 expressions of interest and another other three to be confirmed.
 Participants will need to start thinking about booking accommodation and transport.

Recfishwest Report

No report – Recfishwest has not had a meeting for the year as yet.

Recording Officer Report

- Peter Pekaar has made an application for an artificial bait record, which has been approved.
 Delegates voted in favour of the record being ratified. When John Curtis gets back a certificate will be presented.
- Chris Bunce has made an application for a shovel nose ray record, which has also been approved. Delegates voted in favour of the record being ratified.
- A third application for a bass groper requires additional information from the applicant and lan Cook has written to him.

Competitions Officer Report

• Paul Frzop has received some team nomination forms from clubs for the State Boating Competition.

13. GENERAL BUSINESS

Discussion took place regarding proxy delegates appointed to attend the AAAWA meeting. Clubs are reminded that they must inform the AAAWA secretary in writing (email is OK) prior to a meeting if they intend to appoint a proxy delegate. (Please note: Beachcombers <u>did</u> advise the Secretary prior to January's meeting that they were appointing Mark Hansen as their delegate, delegates may have not been aware of this).

DSR Funding

At John Curtis' request, Terry Fuller checked with Recfishwest about the status of DSR Funding allocations and was asked if the same amount as last year would be acceptable (\$5500). Terry warned that asking for additional funding would involve long and detailed justification on what it would be spent on. It was moved by Mark Hansen and seconded by Gary Evans that AAAWA accept the recommended amount of \$5500 in DSR funding. Motion passed.

Kevin Murphy presented information and some nomination forms for the Marmion Angling & Aquatic Club's Bluewater Classic on Feb 19th, Either individuals or clubs can enter. Entries close on 17th February.
