This meeting is an Information Meeting for persons considering attending the National Angling Championships and Convention to be held at Wallaroo in South Australia in March 2015. Anyone interested in attending the National Carnival is invited to attend this meeting.

George Holman commented that it was short notice for all the people wishing to attend. Two Surf Casters members cannot make the meeting. He also asked why couldn't we have the meeting at a private house? The President noted that the Association would not hold any Association meetings at private houses because of problems from previous years, where some association members were not welcome at those houses.

Joe Horvath asked about the Kalbarri National Park Draft Management Plan 2014, Information had been emailed to all Clubs, and the only one that replied was Kalbarri OAC, and they responded that there were no real problems with the content or intent with the above management plan.

Dennis Loran queried the purchase of pocket badges from Embroidery Design. Pat Shinnick indicated that the company makes the winners badges and that a letter has been sent to have the badges for 2015 State Boat Championships made.

Early Closure of Cockburn Sound Crab Fishery - The Cockburn Sound crab fishery had closed early because of poor recruitment and this had been brought about by environmental reasons rather than recreational or commercial fishing activities.

There is also an early closure to the Shark Bay Snapper Fishery as well, again from poor recruitment. It is closed seasonally from 1 May to the 31 July inclusive.

12. INDIVIDUAL REPORTS

1. President's Report

Closure of the Southern Zone Abalone Season:

The Southern Zone extends from Busselton Jetty to the South Australian Border and permitted to fish that area between 5 October -15 May.

Assistance with Blue Swimmer Crab Research:

The Fisheries Department are looking for people to assist with Blue Swimmer Crab research. They are researching crabs in the Swan & Canning Rivers, Peel / Harvey estuary and Geographe Bay. They are seeking assistance from 50 people to assist in these areas. Further details are available on the Fisheries Website

Barramundi fingerlings released into Lake Argyle.

More barramundi fingerlings have been released into Lake Argyle. Another 200,000 barramundi being released in Lake Argyle, this now bring about 500,000 thousand barramundi being released in the Lake Argyle Martin Humbert asked if it is a catch and release fishery or a catch and keep fishery. The President noted that at present it is a catch and release fishery as they are undersized. As they mature it will be world class catch and keep fishery.

2. Estuary, Rock and Beach Report

Russell Bunce reported on the State Rock and Beach held Cape to Cape on the weekend. There were 63 participants. Geraldton club had sent down a team down and most of the metro clubs attended. Jason and Russell have requested that metropolitan clubs plan to include the AAA events when setting up club Field Day calendars. This would enable clubs to be represented at the AAA events and improve participation.

The Yallingup Beach and Caravan Park management were excellent and helped us out. They donated three sites for the Association to use for the weigh-in and shut down a camping area for that weekend. Linda Ferguson the Yallingup Beach and Caravan Park Manager Linda Ferguson asked about inclusion in a newsletter or perhaps a promotional logo. Russell Bunce is to send a thank you letter and possibly a Certificate of Appreciation similar to those used by the Boating Sub-Committee.

Jason was double checking the results and will forward the details to Terry for inclusion on the Association web site.

One concern arising from the event was that there was only one mini junior and one junior from the Fremantle Club participating in the event.

The weather was a bit hit and miss, with clear conditions on Saturday and a bit of rain late Saturday night and Sunday morning. Russell thought the weather overall for the event was pretty good as the swell was down.

One item to note was that the Association computer used by Jason to record the event has seen better days and needs to be replaced.

Tim Grose from Recfishwest had written to the Association requesting results and any photos be sent to him to show the community spirit of recreational angling and promote general recreational angling.

The President thanked Russell and Jason and their workers for their efforts in making this event a success and thanked all clubs who participated for their efforts.

3. Boating Report

A debrief was held last Tuesday, actually handing out next year's budget and other materials. The Boating sub-committee has paid for the new P A system, a gazebo, and new teardrop banners for use at Association events from this year's budget but all that will be reimbursed from grants funding when received.

The laptop was donated many years ago to the Association so it has not cost anything, I was recommended that the AAA should purchase a new computer and claim it from the next year's funding.

A new Boating Sub-Committee is to be formed. Most members of the previous committee will remain. The new budget is completed and new rule changes have been completed. Nomination Forms and new booklets all been done except for the new advertisements. Letters have been sent to all winners with their badges enclosed.

The new committee will meet on the second Tuesday of each month at 7.30 pm at the ORSSC Clubrooms. Anyone wanting to be part of the committee is welcome to come to the next meeting.

One item arising from the State Boat Championships was the lack of use of charter boats. For the last 15 years charter boats were not able to be used due to what happened at Geraldton. For the last two or three years I have tried to get charter boats in as long as the criteria set by the committee was met. A lot of work was done to allow this to happen, we changed the rules and everyone seemed quite happy. We gave everyone three months to apply and did not have one applicant. I believe it will eventually work as long as the members of the non-boating clubs plan ahead and put in a request to use the charter boats.

Russell Bunce asked about facilities for those participants who participate in boating events and live some distance from the hosting Clubs. Most clubs do have appropriate shower facilities available on their premises.

5. Recording Officer Report

Nothing in this month, however Terry Fuller has requested an update from 2011 onwards he has not updated the State Record or National Charts on the web site. Prior to the National Convention at South West Rocks, NSW put the National records list on their Association website. We are working on an update to the National Claim Application so that it is standard across each State, plus place a note on them to indicate that power assistance of any form is not permitted on reels. W A has links to both State and National Record Charts on its web site.

12. GENERAL BUSINESS

1 Use of unsigned AAAWA Letter Heads

Recently a member of an affiliated club sent an invoice to their club on a made up unofficial AAA letterhead. They sent the invoice to obtain outstanding fees from their club that had not been paid for a couple of years.

The Club Manager had rung the Secretary to ask what is going on why are we sending invoices that are two years old?

The Association Secretary and President knew nothing about the invoice. What was done in this instance is not appropriate business procedure. If an invoice was needed to be raised, a request to the Association Secretary would have had one raised with an appropriate covering letter to the club.

Russell Bunce noted that clubs still signed on at the State Rock and Beach event and paid fees on the day. This left Jason holding a large sum of money and cheques with no secure means of holding it. This is not acceptable.

2 Clubs are to pay for all participants on the nominated date and following discussion it was resolved that there will be no cash taken on the day. Late entries will be noted and clubs will be invoiced for the participants fees plus the late nomination fee.

3 National Carnival Information Night

An information night for any association member considering attending the AAA National Carnival in March 2015 at Wallaroo in South Australia, will be held on the 3rd June at the Sportsman's Association headquarters in Mount Lawley at 7:30 p.m.

- 4 George Holman noted that there had been a debrief of the National Carnival and State Dry Casting events, he requested and asked had there been any minutes written up.
- **5** Ged Woodcock queried the purchase of a replacement laptop for the Rock & Beach subcommittee.

Moved Peter Osborne, Seconded Mark Hansen;, "That the Association purchase a laptop to replace the current one used by the Rock and Beach sub-committee" Motion Carried.

Russell Bunce asked about configuration requirements of the laptop computer and it was resolved that the data from the old laptop be re-installed on the new unit.
